A LETTER FROM ONDINE SHERMAN, VOICELESS CO-FOUNDER AND MANAGING DIRECTOR

How do I recall the last twenty years of Voiceless and do it justice? Countless projects, talks, campaigns, reports, memories, and proud achievements. And too many wonderful team members, supporters and partners to name...

One of the facets that I am most proud of is how Voiceless has remained an intentional, small organisation, nimble and effective in adopting new ways to protect animals by quickly pivoting strategies and jumping on opportunities to create change. Over the years, we have employed diverse and complimentary approaches and methodologies all with the express aim of ending legalised cruelty to animals, as fast as possible.

Our in-depth reports "lifted the veil of secrecy" on industries and made their way into the hands of top lawyers, CEOs and politicians during parliamentary debates. Voiceless lobbied government for key law and policy reforms, planted and grew the field of Australian animal law (and hired Australia's very first animal lawyer!) and toured the world's most effective changemakers across the country as part of our long-running Voiceless Animal Law Lecture series. Including the late great Prof. Steven Wise, animal lawyer and founder of

the Nonhuman Rights Project. Today, members of our audiences, such as law students and seasoned lawyers, credit these Voiceless talks for turning them into life-long animal advocates.

Animals were absent from media platforms and there was virtually no coverage of factory farming or other cruel industries when Voiceless began. By engaging journalists through prizes and networks, Voiceless increased national media exposure of key animal issues. We bolstered animal protection values in the scientific community via the Australian Museum's Eureka Prizes and spread animal protection messages to Australian visual arts and literature communities with arts events and publishing the Voiceless Anthology in partner with our Patron and Nobel laureate. J.M. Coetzee.

Voiceless presented to leading corporates, banks, and law firms on the importance of animal protection as part of their sustainability goals and campaigned for banning and ending cruel practices such as sow stalls, live export and battery cages. Our animal law education team built a national network of educators at law schools, implementing our unique animal law education programmes. We ran a national advertising campaign to end

factory farming, published the Voiceless Animal Cruelty Index (VACI), an online index comparing global levels of government-sanctioned animal cruelty (with Australia shamefully last). And built and strengthened the Australian animal movement with \$2 million in seed funding and grants. Our Animal Protection Education programmes, the first of its kind, and are now used by thousands of students across schools in Australia and N7

Looking back at our twenty years, a few highlights for me personally were Voiceless's 2015 groundbreaking report, The Life of the Dairy Cow, as I learned, together with my team, about the terrible suffering of mother cows and calves. Voiceless's powerful printed 'recipes' in Australian top magazines detailing cruelty in pig, dairy and chicken industries; and our Animal Protection Education resource focusing on broiler chickens, a lesser known but key animal cruelty issue, also come to mind as proud moments of changing hearts and minds.

Today, I feel excited about new and emerging opportunities in the animal protection space. A raft of initiatives that enable win-wins across often opposing sectors. As part of our Voiceless Grants

Program, we are investing in solutionsbased projects such as Farm Transitions Australia. The concept of transitions, now a global movement, helps farmers move from animal agriculture to plant-based industries, a win-win for all parties – animals, people and the environment.

Another example is plant-based food tech helping companies provide consumers with the product they love without animal cruelty, environmental cost or economic loss. That's a success for companies, animals and the environment. Voiceless Grantee, Vegan Friendly is excelling in this space, saving tens of thousands of hens in the battery egg industry with a simple animal-free revision, in partnership with a major food company, of a favourite retail cookie.

I'm also excited about co-existence work, as too often wildlife and humans are perceived to be in conflict with a devastating cost to animals who are often shot or cruelly poisoned. We are excited to work with Kangaroos Alive in the area of kangaroo-farmer co-existence, developing strategies that enable farmers to see profits at the same time as protecting animals.

Over the years we've been blessed with smart, thoughtful, kind team members, each of whom brought their gifts and some of whom have remained together with us today as part of our Board of Directors or community of supporters.

I want to acknowledge the great losses of my beloved father, Co-founder and Joint Managing Director, Brian Sherman AM as well as my dearest friend and colleague, Elaine Morris.

Without my wonderful father, Voiceless simply would not exist. Founding Voiceless together as a father-daughter team back in 2004, we formed a unique and true partnership and did not have a single disagreement about our vision, despite different styles and strategies. My father's passing in 2022 was a seismic, earth-shattering loss and I dedicate this anniversary report in his honour.

My other Voiceless partner for nearly twenty years was Elaine Morris, whose love for animals and devotion to Voiceless was unparalleled. In 2004, pregnant with my first child, Elaine jumped in to be my 'maternity-leave' and Voiceless' first team member. She proved her worth a million-fold, running Voiceless seamlessly as COO and never left. Elaine passed five years ago, and we miss her with all our hearts.

Looking ahead, I am delighted to continue working together with the wonderful Voiceless General Manager, Kate Grigg along with our Board of Directors, Advisory Group, pro-bono supporters and many other partners and allies to continue creating change for animals.

Twenty years ago, animals were suffering and dying in their billions due to human exploitation and violence and urgently needed our voice. They still are today, and we have a long hard road to continue. As on the first day that my father and I founded Voiceless, I do believe that together, we can and will make a difference. However, my aspiration is that our work to promote animal rights and flourishing will eventually create no need for Voiceless or other animal organisations. That may seem a utopian future, but it's in our reach.







Kate Grigg, General Manager, reflects on the VGP

The Voiceless Grants Program (VGP) has exceeded my expectations in terms of the value it plays for both the grant recipients and the animals we are all working for. By fulfilling a vital need within the animal protection movement with financial and trust-based support, the VGP allows animal advocates to realise their ideas and projects with the network, support system and encouragement they need to create real and lasting changes for animals. For me personally, Voiceless and the VGP allows me to contribute to protecting animals in a positive, uplifting, and solutions-led way.

Why the Voiceless Grants Program (VGP)?

New and different animal advocacy strategies are required to achieve meaningful change and address the root causes of animal exploitation that shape the world that we live in.

Eighty billion land animals and up to three trillion fishes are consumed globally each year and experience routine confinement, transport and slaughter.

These sentient animals experience lives of abject suffering and deprivation through legalised and institutionalised cruelty. Millions more land animals are exploited for their fur and skins, or used for sports, trophies and other human entertainment with little concern as to their experiences.

A long history of anthropocentric values and speciesism has allowed humans to consider animals as property, things, killable, with little moral value or use beyond human desires.

What is our Theory of Change?

Voiceless invests in and empowers visionary people and transformative ideas to create positive change and reforms for animals in our social, political, and legal framework.

We encourage advocacy that challenges the status quo, increases critical thinking about deep-rooted, anti-animal beliefs and disrupts anthropocentric attitudes. Through this approach, we can reform systems of legalised animal exploitation and cruelty, and see animals begin to flourish on their own terms.

2022 GRANT RECIPIENTS

Australian Alliance for Animals

As a core member, Voiceless supported the Australian Alliance for Animals policy reform program, intent on establishing a national and Independent Office of Animal Welfare to repair Australia's broken animal welfare system and achieve beneficial reforms for Australian animals.



Israeli Human and Animal Institute

The impactful and youth-focused organisation, The Israeli Human and Animal Institute, developed the empathy-based 'Animals with Us' primary school coursework program with support from Voiceless. 'Animals With Us' encourages human and animal connection via video and web-based tools and has now been used as an educational tool in over 2,000 classrooms across Israel.



Little Oak Sanctuary

Creating a brighter future for animals through their empathy-based primary school education program and workshops - 'The Compassionate Classroom.'



Farm Transitions Australia

Voiceless was proud to invest in the beginnings of the innovative, Farm Transitions Australia (FTA), who provide free assistance, tools, resources and business support services to animal-based farmers wanting to transition their farms and embrace new opportunities in plantfocused agriculture. 12 months on, FTA are undertaking their first two farm transitions with a beef and dairy farmer and creating a more compassionate future for animals, people and the planet.



2023 GRANT RECIPIENTS

Vegan Friendly

The Food Engineering project collaborates with food producers to replace animal products with plant-based alternatives in popular consumer products, maintaining taste, texture, appearance, and cost. By partnering with top food companies, the project has removed the use of animals from the supply chain for dozens of products. Over 1 million eggs from hens confined to the battery cage system and thousands of litres of cow's milk from the dairy industry, have been eliminated so far. The project will continue to expand with more food manufacturers and products in 2024.



Alternative Proteins

Food Frontier, Australia's preeminent alternative proteins research and advisory organisation, led the 2023 Alt Proteins CRC bid. This initiative aimed to solve challenges and unlock new opportunities to grow the alternative proteins market in Australia and help advance alternatives to animal products from industrial animal agriculture.



Collective Fashion Justice

'Total Ethics Fashion' by Emma Hakansson integrates animals into fashion sustainability discussions. This manifesto for the fashion industry prioritises the wellbeing of all animals and the planet over profit. It has gained acclaim both locally and internationally, with availability in major book retailers across Australia, the UK, and the US, translation into Italian, inclusion in major fashion education reading lists, and discussion at the 2024 Copenhagen Global Fashion Summit.



Kangaroos Alive

2023 World Kangaroo Day celebrated co-existence with kangaroos and our First Nations People's perspectives on kangaroo protection and their cultural significance.

A partnership with organisation, Back to Country was cemented to drive education about the cultural significance of the kangaroo to First Nations Australians

via the Yuin Declaration adoption across Australian councils and the Kangaroo Walks and Talks Program.

Media coverage of World Kangaroo Day 2023 reached an estimated audience of 25 million people.



The Pollination Project - African micro grants

Voiceless has been bolstering Africa's nascent animal protection movement through our partner, The Pollination Project. Through a series of seed grants, the aim is to grow animal and plant-based advocacy in small, local communities, demonstrating that small changes lead to significant results.



Animalex

The world's first global animal law educational resource library and network hub grows the animal law movement and recognises the increasingly important role lawyers are playing in advocating for and advancing animal rights. The collaboration between the Centre for Professional Legal Education at Bond University and the Center for Animal Law Studies at Lewis & Clark Law School will launch in mid-2024 and will make animal law educational resources freely accessible to everyone and connect animal law teachers, researchers, advocates, attorneys, and students across the world.



Nup to the Cup

The Coalition for the Protection of Racehorses and their 2023 Nup to the Cup campaign, encourages the celebration of horses instead of their exploitation.

From humble beginnings in 2010, the Nup to the Cup movement has been gaining momentum and community support by successfully raising awareness about the inherent cruelty of horse racing.



Creating a Vegan World

Documentary, Creating a Vegan World spotlights the most effective strategies and ideas from animal advocates worldwide. Years in the making, film-makers Andrew Alexander and Sarah Martin have interviewed hundreds of global leaders in the vegan, plant-based health, and environmentalist movements and have identified the fastest ways to end the exploitation of animals and transition the world to sustainable plant-based agriculture. Currently in post production with a launch date coming soon.



2024 GRANT RECIPIENTS

Greyhound Protection

A coalition of greyhound protection organisations progressing strategies to influence public opinion and target state governments to commit to a ban on this cruel industry. This included

commissioning consumer polling research to spotlight the negative consumer sentiment towards the greyhound racing industry and its ongoing receipt of government funding.

Defend the Wild

Defend the Wild's documentary, *Native Pest*, examines the dual perception of dingoes in Australia as both pests and ecological stabilisers. The film explores



the cultural significance of Australia's indigenous canine and the tension between nature and agriculture.

Farm Transitions Australia

Farm Transitions Australia's commission of a National Dairy Farmer Survey spotlighted willingness of dairy farmers to consider animal-free futures.

Over one-third of dairy farmers



expressed a willingness to transition away from dairy farming. With Voiceless support, Farm Transitions
Australia can offer farmers a pragmatic roadmap away from animal farming.

Australian Alliance for Animals

As another live export disaster unfolded, with 16,000 animals stranded on board the MV Bahijah in the heat of summer 2024, Voiceless joined and supported the



Australian Alliance for Animals (and the broader End Live Sheep Exports working group) to continue lobbying for a national phase-out of the live sheep export industry and an Independent National Animal Welfare Commission. In May 2024, the Australian government announced that it would end this cruel trade by 1 May 2028.

Modern Agricultural Foundation

Bolstering outstanding female leadership within the Alt Proteins field through the Modern Agriculture Foundation (MAF). MAF are on a mission to accelerate the growth of the alternative protein ecosystem, foster high-impact innovation, spark entrepreneurship and nurture a collaborative community locally in Israel and globally. With 30% of the food tech sector led by women, and only 4% of these visionaries funded by venture capitalists, MAF is advancing the Alt Proteins ecosystem for females and creating the future of food.



HOW VOICELESS IS MAKING A DIFFERENCE

Hear from our community of animal changemakers about how Voiceless has made the work desperately needed for animals, a reality.

Without the support of organisations like Voiceless, our mission and our work with farmers would be a far-off dream. With the grant that we have received from Voiceless, I'm proud to announce that we have just commenced our first farm transition, supporting a beef farmer in New South Wales, transitioning him away from farming and into an Agritourism business model. We're also looking at a sanctuary for his beautiful 800 Angus cattle. GIVING TO THE ANIMALS

"Angel donor", Lara Goodridge speaks about her lifelong affinity with and understanding of animals, and how human violence and cruelty towards them inspires her giving.

What was the catalyst for your interest in animal protection?

I tried to become vegetarian at the age of 6 or 7 when my Dad made a joke about a truckload of lovely sheep driving alongside us being on their way to becoming lamb kebabs. It was the first time I really put it together. The horror. Those beautiful, innocent animals on their way to slaughter. I didn't succeed in staying vegetarian then, but I did from 15 onwards. I stopped wearing leather and started a life of more mindfully choosing as little violence against animals as I could in my life. I love being around animals. There is a purity to their existence that is both innocent and wise. Our cruelty towards them is deeply disturbing to me.

How would describe Voiceless to others?

I would describe Voiceless as a visionary organisation who you can trust to do the hard work, and the most valuable work possible through research and action.

What inspired your gift to Voiceless?

Voiceless has been one of the most impressive and exciting organisations in animal protection in the last two decades. There is a meticulously researched approach to everything they do that is incredibly inspiring and exciting to watch, and the scope of their work over this time has been vast. Most recently, getting behind other working organisations who are equally dedicated to the welfare of animals is such a great way of strengthening existing work being done out there. Empowering these smaller organisations to build on their skills and resources seems to me to be a clever way of exchanging knowledge and skills. It feels like a very practical and resourceful way of expanding the networks of like-minded people with the common aim of reducing animal harm, both locally and globally.

What do you see as the most important changes needed to ensure our vision of a just, equitable world where animals can flourish?

We as humans have chosen dominion over the earth over cooperation and collaboration. As a result, we have denuded our landscapes and created a violent world to both the environment, and to those who live on it. We must see ourselves as part of an ecology, rather than as overlords, exploiting the land and all our inhabitants.

Although there is still much to be done. Voiceless's work has seeded many leaders in animal law and helped ensure that this field continues to gather momentum for decades to come.


